CIVIL:

1. If the parties agree that they wish the pretrial to be heard, they should contact the Trial Coordinator who will provide a non-negotiable date for the pretrial and the coordinates to connect to the pretrial. Counsel must have access to the instructing party at all times during the hearing. Pretrial briefs must be concise, in WORD format and should be emailed to the Trial Coordinator for distribution to the judge 3 days before the hearing.
